1. Teresa's notes from Friday Portland team meeting re: planning Marshall:

Portland core team seems excited about targeted or more advanced training, rather than an intro.

Want shared understanding w/strategy of corporate sponsorship and Portland team's wishes for Marshall and bringing into the revenue of the organization.
